1. Minutes

2. ACC Report

3. Homeowners' Comments and Concerns

Homeowners raised questions about how members of the ACC are chosen and how long they serve. The Board clarified that pursuant to Article VI, Section 2 of the Second Amended and Restated Covenants, Conditions and Restrictions of Shady Hollow Estates, the ACC consists of five members appointed by the Board, and each member appointed serves a term of two years. Each year, there are either two or three terms that expire and the Board appoints persons to fill those positions at the first regular HOA meeting of the year. Homeowners interested in serving on the ACC can volunteer anytime by submitting their name to the President of the Board, who will keep a list of names to be considered at the next appointment.

4. Property Manager's Report

- The HOA has an account balance of \$42,261.51. Delinquency report provided. No unusual expenses.
- The Board unanimously approved the 2018 Budget, which added new funds to address oak wilt assessment and support social events. Expenses outweigh net income by \$2,405.00.

5. Old Business

- 12504 Black Mesa Cove Homeowner has agreed to a disclosure to put prospective buyers on notice that use of the property as a wedding venue violates the CC&Rs. Attorney representing Homeowner has not responded to attempts to contact him and finalize the language.

- Oak wilt assessment has been completed. Report has not yet been received.
- Speed notice sign on Lost Oasis is blocked by trees. Vendor will need to come back and move the sign.

6. New Business

- Selection of ACC members Current ACC members whose term expired again expressed interest. There were no other Homeowners on the list to be considered. Board unanimously reappointed those ACC members.
- Flags the Board voted unanimously to participate in the Grand Old Flag Fundraiser. For \$90, two flags will be placed at the entrance on six different holidays during the year.
- Social Committee The Board voted unanimously to create a Social Committee pursuant to Article VI, Section 1(i) of the Bylaws. The Board appointed Jamie Brown as the Board representative on the Committee and nominated Homeowner Julie Moore as the Committee Chairperson. The budget for social activities in 2018 is \$1500.
