AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS THE ESTATES OF SHADY HOLLOW (FORMERLY KNOWN AS SHADY HOLLOW ESTATES) February, 2002



Whereas the Declaration of Covenants, Conditions and Restrictions for Shady Hollow Estates (now known as Estates of Shady Hollow) was recorded in Volume 8545, Page 673 of the Deed Records of Travis County, Texas (together with all subsequent amendments thereto, the "Declaration"), and

Whereas the Declaration contains procedures for amendment of the Declaration by the homeowners association members, and those procedures have been met;

The Declaration is hereby amended as follows:

Article VII, Section 16 of the Declaration entitled "Oil, Gas, and Mining Operations; Water Wells" is hereby amended to delete any reference to "water wells" so that this section now reads in its entirety:

"Section 16. Oil, Gas, and Mining Operations. No oil or gas exploration, drilling or development operations or oil or gas refining, quarrying or mining operations at any time shall be permitted upon or within any portion of the Property, nor shall oil wells, tanks, tunnels, mineral excavations or shafts be permitted upon or within any portion of the Property. No derricks or other structure designed for use in boring for oil or natural gas shall be erected, maintained or permitted upon any portion of this Property."
